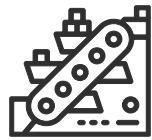

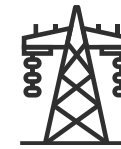

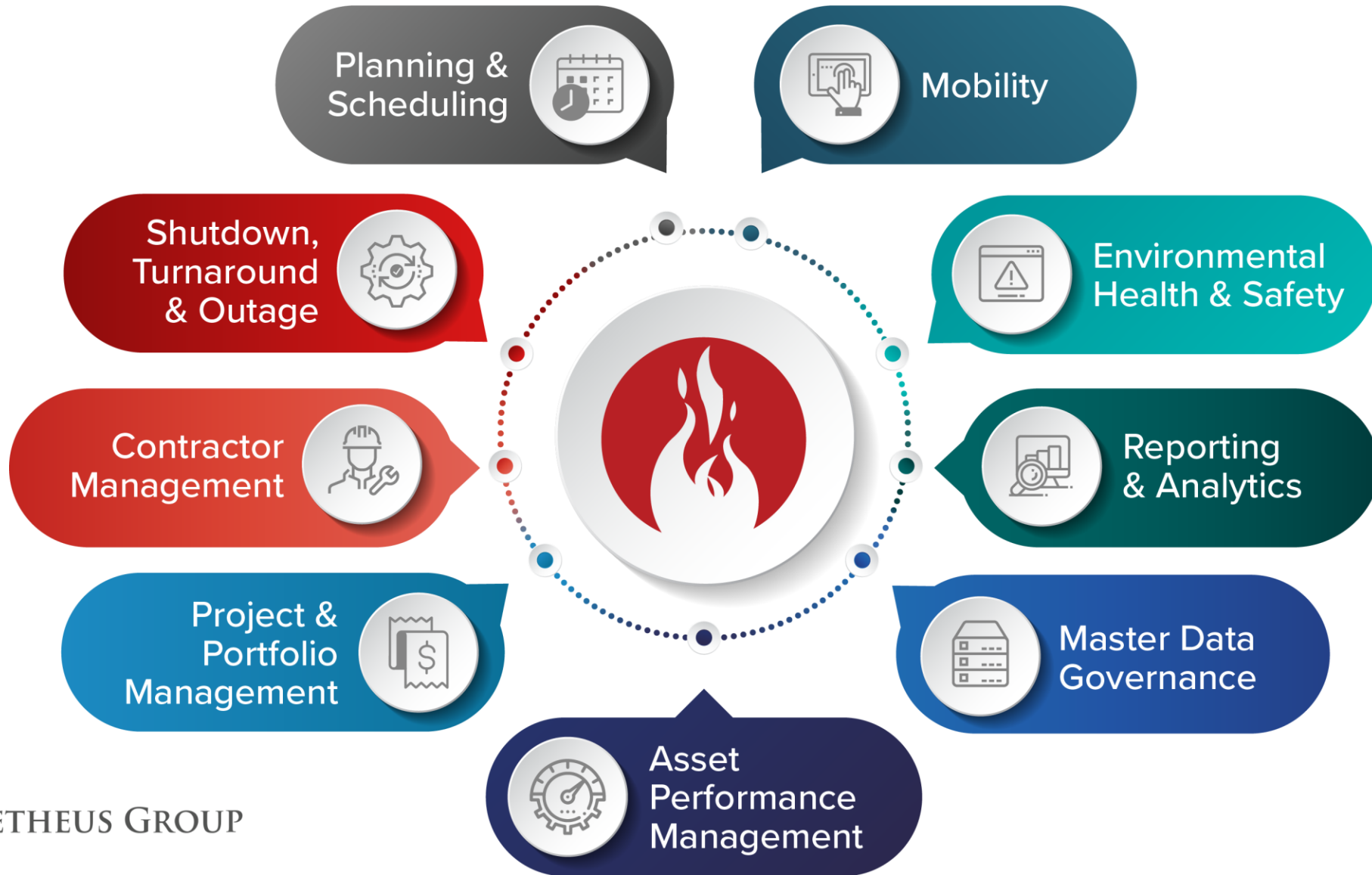

Reviewing and Identifying Gaps

- Assessing your current permitting process
- Identifying areas for improvement
- Challenges with current permitting systems
 - Lack of visibility and real-time tracking
 - Manual and time-consuming processes
 - Difficulty in enforcing compliance
- Issues with using paper permits
 - Prone to loss, damage, and misplacement
 - Manual data entry and transcription errors
 - Limited approval and collaboration accessibility
- Issues with using digital permits
 - Learning curve and resistance to change
 - Technical issues
 - Data security



Permitting Digitalization

- Is your organization digitizing your current permitting process?

Transitioning From Paper to Digital Permitting

- Creating a path to digital permitting
 - Assessing current needs to rolling out your solution
- Ensuring smooth change management with personnel
 - Involve early and often
 - Training and other learning before implementation
 - Encourage Participation



Additional Ways of Streamlining Safety

- CMMS Integration
 - Create a permit automatically from a work order
 - Link asset hierarchy
- Permit templating
 - Have a template for turnaround events to increase efficiency
 - Easier creation of standard permits
- HIRA
 - Digital library of any work categories, hazards, and controls
 - Reduce the amount of permits needed for operations
 - Maintained by the customer



EPAS Digital Permitting Enhancements

- Electronic Permit to Work
- Embedded risk assessments
- Localized customer content management
- Lockbox/Keysafe Management
- Smart P&ID
- Workflow support (e.g., confined space, hot work, etc.)
 - Dynamic rule configuration
- Integrated incident logging
- Audits
- GIS Integrations
